Article 1 of the Uniform Commercial Code (UCC) applies to contracts of sale of goods between parties whose places of business are in different states. (a) when the states are contracting states or (b) when the rules of private international law lead to the application of the law of a state.

A sale of goods agreement, also sometimes called a sales agreement or sales contract, is a document that a buyer and seller can enter into when a certain good or certain goods are being sold. Through a sale of goods agreement, a seller and buyer can outline the terms and conditions of the sale of the item or items being transferred.

Cost of Goods Sold (COGS) refers to the direct costs of producing the goods sold by a company. This amount includes the cost of the materials and labor directly used to create the good.
