was a gift, passed down to him from St. Ignatius, the founder of the Jesuits, who described his own struggle with discernment in *Spiritual Exercises of St. Ignatius*. The Twelve Steps of AA and the *Spiritual Exercises of St. Ignatius* presuppose that there is a caring God whose will can be known. The act of tuning in to God's action at one's center is discernment. The big question is, how do you know your Higher Power is speaking and revealing Himself through your feelings and desires? What Bill learned from Father Ed can be found in books and articles he wrote for AA. For the good of AA and himself, Bill learned to listen to his desires, be aware of his inner dynamics, and tune into the action of God within. Doing this meant learning to recognize and identify his personal movements -- those inner promptings and attractions often called emotions or affections -- which are part of ordinary human experiences.
